**Ternopil Ivan Pul'uj State Technical University** and National Technical University of Ukraine "Kyiv Politechnical Institute" the undersigned education institution agree to the terms and conditions stated herein. Legal liability in this agreement shall be subject to the common practices of liabilities practiced among government/non-profit agencies.

1. Ternopil Ivan Pul'uj State Technical University (as a Regional Cisco Networking Academy, in partnership with Cisco Systems) Agrees to:

- \* Provide access to the Cisco Networking Academy Curriculum.
- \* Train 2 instructors associated with the Local Academy in all four semesters of curriculum.
- \* Evaluate, monitor, update and audit the Program in order to improve the instruction delivery process and assure the Local Academy of current content and practical "hands-on" instructional experiences for students.

2. National Technical University of Ukraine "Kyiv Politechnical Institute" (as a Local Cisco Networking Academy) Agrees to:

- \* Offer the four semester of the curriculum to students within that Local Academy
- \* Nominate two individuals from the Local Academy to attend, and pass with a satisfactory grade, the twenty days of CCNA training. This training to be held at Ternopil Ivan Pul'uj State Technical University.
- \* Ensure that trainers pass the CCNA certification exam
- \* Purchase the specified Cisco equipment package from a recommended Cisco Academic Partner/Reseller giving sufficient time for its arrival BEFORE Semester 1 instruction begins. Normal delivery lead times are between 4-6 weeks. (See Appendix A for necessary Equipment).
- \* Provide an instructional space large enough for both a training area and network practice area as specified in Appendix A
- \* Deny access to the Cisco Networking Curriculum to the general public in either electronic or print form.
- \* Provide a summary of class activities upon completion of each semester, including "hands-on" student projects.

3. Ownership

\* The Regional Networking Academy, acting on behalf of Cisco Systems shall retain all rights, title and interest in and to the Curriculum.

4. National Technical University of Ukraine "Kyiv Politechnical Institute" costs to Ternopil Ivan Pul'uj State Technical University

The Local Academy does not pay any charges to the Regional Academy.

### 5. Billing Procedure:

\* Upon receipt of this signed agreement, Ternopil Ivan Pul'uj State Technical University will invoice your institution the appropriate fee (under clause 4 of the agreement).

#### 6. Termination of Agreement:

- \* Either party may terminate this Letter of Agreement in writing by providing six months notice. Upon such termination, Local Academy shall return all Cisco Curriculum to the Regional Academy.
